

## Beurt R. Ser Vaas

The Commencement address will be delivered today by Dr. Beurt Richard SerVaas, a distinguished Hoosier citizen who has achieved success as a businessman and who has unselfishly lent his expertise to public service. The University will honor him for his achievements with the conferral of an honorary Doctor of Laws degree.

As Chairman of the Board of SerVaas, Incorporated, he directs the activities of a dozen affiliated companies in the Americas and in Europe. Among those businesses is Curtis Publishing Company, which publishes the Saturday Evening Post and several other magazines.

The same entrepreneurship he has employed to turn marginal businesses into successful ventures has been equally effective



in serving the public sector. Much of the activity which has revitalized Indianapolis may be traced directly to Dr. SerVaas' vision of a better capital city for Indiana.

He was architect of the plan for unified city and county government in Indianapolis and Marion County, Indiana. He has served as an elected councilman since 1962 and for the past nine years has been President of the City-County Council. His efforts to improve downtown Indianapolis have included such significant developments as Market Square Arena, the Hoosier Dome, the Veladrome, and the Indiana University Natatorium.

As a member of the Indiana Commission for Higher Education, which he now serves as Vice Chairman, he has sought improved access to public education for all Hoosier citizens. The statewide system of medical education, which has a center in Evansville, is the result of Dr. SerVaas' work as Chairman of the Governor's Commission for Medical Education. He is also a member of the Board of the National League for Nursing.

Dr. SerVaas attended the University of Mexico, Mexico City, and graduated from Indiana University with the Bachelor of Arts degree in chemistry, history and Spanish. He entered graduate school at Purdue University in 1941 as a DuPont Scholar in chemistry, but his education was interrupted by military service. From 1941 to 1945, he served in the U.S. Navy as an intelligence officer, and became Chief of Intelligence for the China-Burma-India Theatre. He was awarded the Doctor of Medical Science degree in 1970 from Indiana University. Dr. Ser-Vaas continues his interest in medicine through activities which enhance medical advancements and education.

Earlier this year, Dr. SerVaas was awarded the Benjamin Harrison Medallion of the Columbia Club of Indianapolis for excellence in public service. Both Butler University and the University of New England have recognized him with honorary degrees.



## Gertrude E. Mitchell and William H. Mitchell

The University will confer honorary Doctor of Laws degrees today on Gertrude E. Mitchell and William Henry Mitchell. As individuals and as a couple, Mr. and Mrs. Mitchell have made inestimable contributions to improving the quality of life in the tri-state region, which is their community. The Albion, Illinois, residents have taken a special interest in Evansville-based organizations whose resources they consider vital to regional development.

Mrs. Mitchell pursues her interest in improving health care services in the tri-state through her membership on the Board of Directors of the Deaconess Hospital Foundation. The continuing concern of Mr. and Mrs. Mitchell has directly resulted in better cancer care facilities at

the Hospital, and the Mitchell Pavilion of the Deaconess Health Sciences Building stands as a monument to their caring spirit.

For many years, Mr. Mitchell has encouraged young people to pursue their ambitions through formal education. His work as a member of the Board of Directors of the ISUE Foundation is an extension of that interest. As with all their activities, Foundation projects are shared ventures for the Mitchells who are members of the ISUE President's Council, the 8600 Club, and the Second Century Club. They both participated in planning the University Home and in raising funds for the Foundation project.

Mesker Zoo considers the Mitchells their ambassadors of good will. Their zeal for Zoo activities, from the adopt-an-animal program to the development of a new primate exhibit, has brought new friends into the Zoological Society's ranks.

Bill and Trudy Mitchell were married in 1947 after a two-year courtship in Nürnberg, West Germany. They met when Mr. Mitchell was a young soldier with the military police, assigned to the Nürnberg Trials. Mrs. Mitchell was an East German emigre who had escaped her homeland shortly before her family was sent to a prison camp. Her textbook English, learned at the City College of Werbau, East Germany, where she earned a bachelor's degree in business administration, helped her as she sought to establish a new life in a new country. After their marriage, the couple returned to Mr. Mitchell's hometown of McLeansboro, Illinois. Mr. Mitchell worked in the oil business there, and later in West Salem, Illinois, before moving to Albion thirty years ago.

Mr. Mitchell is President of M & M Oil Company and a Director of People's National Bank in Grayville, Illinois. An active Mason, his home lodge in West Salem is named for him in recognition of his numerous contributions.

### Scholarship Honors

The student graduating with the highest scholarship index will be graduated summa cum laude. Students graduating with a scholarship index of 3.80 or higher will be graduated magna cum laude. Those with a scholarship index between 3.60 and 3.80 will be graduated cum laude. These achievements are set forth on the individual diplomas. Honor students can be recognized in the commencement exercises by the colored stoles and tassels. Gold indicates summa cum laude; red, magna cum laude; and blue, cum laude.

### Academic Dress

The academic costume dates from medieval days when university students wore woolen and fur garments for warmth in damp and drafty buildings. Most of those studying were clerics in the holy orders; they wore a cloak to which was attached a hood that could be pulled up to cover their tonsured heads. Simplified today, the costume serves to remind us that its wearer is a member of an ancient and venerable profession; it also indicates by its color and design its wearer's degree and its institution by which the degree was conferred.

In the United States, black has been the traditional color for academic gowns, but some institutions authorize holders of their doctorates to wear colors of the institution. The bachelor's gown is distinguished by its long, open sleeves; the master's by its closed, slitted sleeves; the doctor's by its full sleeves trimmed with bands of velvet, which may be black or a color denoting the field in which the degree was taken.

The mortarboard cap, proper for all degrees, is black. Tassels, usually black, are worn over the left front quarter of the cap. Holders of the doctorate may wear tassels of gold thread.

Academic hoods vary in length according to the degree and are lined with the colors of the institution by which the degree was granted. The honorary doctoral hoods of Indiana State University are black, lined with blue satin with white satin chevrons. They are edged with velvet trimming of black to match the gown.
