# President Landini To Address Graduates

The 1976 Commencement Address will be given by Richard G. Landini, President of Indiana State University. President Landini is completing his first year as President of ISU. He is the eighth president in the 110-year history of the University.

Prior to accepting the presidency of Indiana State University, President Landini was Academic Vice President at the University of Montana for five years. Earlier he was at Arizona State University for eleven years. He held administrative positions there as Assistant Dean of the graduate school; Dean of Litchfield College, the first unit of a cluster-college branch campus of Arizona State University; and he was Professor of English. His academic area as a teacher has been English, American, and world literature. He is an expert on T. S. Elliott and Ezra Pound.

President Landini, the grandson of an Italian sculptor who migrated to America from the Tyrolean Alps, said he moved from teaching to administration ten years ago when student unrest and academic turmoil was mounting "because I wanted to be in on the beginning and preserve the best of what was worth preserving while responding to the changes in society."

President Landini is a member of a variety of professional societies and has published extensively in scholarly



journals. During the 1966-69 period, he wrote approximately 40 book reviews for the Arizona Republic. He has presented papers at meetings and conventions of the National Council of Teachers of English, Rocky Mountain Modern Language Association, Southwest Alliance for Latin America, and Pacific Northwest Conference on Higher Education.

Commenting on the future of higher education, President Landini said, "The job before all of us in higher education - faculty and administration - is to preserve the best of tradition, that which is worth preserving. We have to take a long look at new configurations breaking into adult education. And talent must be developed to solve the energy problems we face."

President Landini describes himself as a gregarious family man who enjoys backpacking vacations, golfing, and English literature. A native of Pittsburgh, President Landini and his wife, Phyllis, have five children. He holds degrees from the University of Miami and the University of Florida.

# Three Merit Highest Recognition

Two Evansville businessmen, Rolland Eckels, Public Affairs Director of Mead Johnson Company; Byron Hubbard, Chairman of the Board of Evansville Sheet Metal Works; and Mt. Vernon businessman, Malcolm Fuhrer, retired President of Fuhrer-Ford Milling Company, will be receiving honorary degrees in the ceremony today.

Rolland Eckels, a 1949 honor graduate of the University of Evansville, served as a staff sergeant in the United States Army Air Corps during World War II. Before beginning his affiliation with Mead Johnson Company, Mr. Eckels served as Athletic Business Manager at the University of Evansville, as Executive Vice President of the Connersville Chamber of Commerce, and as Executive Director of the United Fund of Evansville and Vanderburgh County. In 1962. Mr. Eckels was appointed Manager of Community Relations at Mead Johnson Company, later to become Manager of the Division Promotions and finally Director of Public Affairs

His community service record includes offices and appointments with Southern Indiana Higher Education, Inc., Evansville Chamber of Commerce, Epilepsy Foundation of Indiana, YWCA Board of Trustees, Evansville Goodwill Industries, Indiana Council for Economic Education, and Evansville's Future.

Mr. Eckels is married and he and his wife, Phyllis, have three children. He will receive the Doctor of Laws degree.

President of Evansville Sheet Metal Works for 27 years, Byron Hubbard is now serving as Chairman of the Board and a son has taken over the presidency. Throughout his business career, Mr. Hubbard was an active member of the Foreman's Club, served as its President in 1956, and has continued in capacity of Budget Director since that time.

Other civic endeavors of Mr. Hubbard include Co-Chairman of United Fund,

member of the Cancer Equipment Drive of Deaconess Hospital, Director of the Evansville Triplets, Chairperson of the administrative board of Simpson Church, and President of the ISUE Screaming Eagles Varsity Club.

A generous contributor to higher education, he and his wife, Marjorie, are members of the Indiana University Tip-Off Club and the University of Evansville 100 Club, and the Century Club, Varsity Club, and Donor Recognition Program of Indiana State University Evansville. They are the parents of three sons and one daughter. Mr. Hubbard will receive the Doctor of Laws degree.

A Mt. Vernon, Indiana native, Malcolm Fuhrer's descendants were Mt. Vernon settlers. His grandfather, William Fuhrer, established a flour milling business in Mt. Vernon in 1885. For thirteen years the mill flourished, until it burned. The following year, William Fuhrer, his son, Eugene, and several New Harmony, Indiana businessmen established the Fuhrer-Ford Milling Company. Malcolm joined the firm in 1915 after graduation from the University of Michigan. He was active with the mill until his retirement.

Malcolm Fuhrer devotes his time to farming and many Mt. Vernon community projects. He is a member of the Board of Directors and Vice President of People's Bank & Trust Company, past member of the Board of Directors of Southern Indiana Gas & Electric Company, and a member of the Deaconess Hospital Foundation. Interested in the youth of his community, Mr. Fuhrer helped organize Junior Achievement for Mt. Vernon and has been active in American Field Service seeking exchange students for the Mt. Vernon area.

The Doctor of Laws degree will be conferred upon Mr. Fuhrer.

### Academic Dress

The academic costume dates from medieval days when university students wore woolen and fur garments for warmth in damp and drafty buildings. Most of those studying were clerics in the holy orders; they wore a cloak to which was attached a hood that could be pulled up to cover their tonsured heads. Simplified today, the costume serves to remind us that its wearer is a member of an ancient and venerable profession; it also indicates by its color and design its wearer's degree and the institution by which the degree was conferred.

In the United States, black has been the traditional color for academic gowns, but some institutions authorize holders of their doctorates to wear the colors of the institution. The bachelor's gown is distinguished by its long, open sleeves; the master's by its closed, slitted sleeves; the doctor's by its full sleeves trimmed with bands of velvet, which may be black or a color denoting the field in which the degree was taken.

The mortarboard cap, proper for all degrees, is black. Tassels, usually black, are worn over the left front quarter of the cap. Holders of the doctorate may wear tassels of gold thread.

Academic hoods vary in length according to the degree and are lined with the colors of the institution by which the degree was granted. The honorary doctoral hoods of Indiana State University are black, lined with blue satin with white satin chevrons. They are edged with velvet trimming of black to match the gown.

#### SCHOLARSHIP HONORS

The student graduating with the highest scholarship index will be graduated summa cum laude. Students graduating with a scholarship index of 3.80 or higher will be graduated magna cum laude. Those with a scholarship index between 3.60 and 3.80 will be graduated cum laude. These achievements are set forth on the individual diplomas. Honor students can be recognized in the commencement exercises by the colored fourrageres; gold indicates summa cum laude; red and white, magna cum laude; and blue and white, cum laude.
