PRESENTATION OF RESOLUTION HONORING DR. LINDA L.M. BENNETT

Read by Andrea Gentry, Chair See Appendix A.

Dr. Bennett remarked how critical service on Administrative Senate is for the University. Administrators touch every corner of campus, and the chair's inclusion on President's Council allowed vital two-way communication to occur.

GUEST

Mr. Richard Toeniskoetter, chief information officer, shared basic information about the shift to OneDrive, which was implemented a year ago. Employees and students can access their information from anywhere, even without a VPN connection. Richard clarified that Microsoft has two different models of OneDrive, one for business managed by USI and one for personal use. IT is in the process of moving everyone's operating system to Windows 10 as it works more seamlessly with OneDrive than older versions. USI has been exploring two-factor authentication with a small group of individuals. When logging into a work computer, a code might be texted to a cellular phone and then provided to complete the login process. Richard recommended that we review our own personal accounts to activate two- or multi-factor authentication (MFA) as many places as possible. He showed some of the features of OneDrive which includes being able to roll back files to past versions. Microsoft has also rolled out ways to mark the privacy levels for certain files; certain levels of privacy result in restricting who can open the file, send it in an email or even screen-capture it.

Richard also discussed SharePoint which is a feature found within OneDrive. A handful of groups have been early adopters of this feature, and eventually all network drives will move to SharePoint. In other updates related to security, newer versions of Windows ask whether the sender wants to send the actual file or a link to the cloud. Finally, Richard demonstrated how to send a message with manual encryption but also cautioned us to be wary if we received an encrypted email unexpectedly, as it could be a phishing or hacking attempt.

WHEREAS, Dr. Bennett continued the physical growth of campus with the addition of numerous facilities; and

WHEREAS, Dr. Bennett was key in the success of Campaign USI: Elevating Excellence which surpassed its \$50 million goal and raised \$57.1 million in support of the University; and

WHEREAS, Dr. Bennett ensured academic achievement remained a priority within USI Athletics and celebrated three NCAA Division II National Championship teams during her tenure; and

WHEREAS, Dr. Bennett approved the formation of USI Administrative Senate less than one year into her presidency and welcomed it, along with Faculty Senate and Staff Council, to the table of President's Council; and

WHEREAS, Dr. Bennett is a professor of political science and made time to remain in the classroom to keep a pulse on the student and faculty experience; and

WHEREAS, Dr. Bennett led initiatives focused on enrollment and retention management, outreach and engagement, faculty development, retention of intellectual capital, accreditation renewal, and long-range planning; and

WHEREAS, Dr. Bennett remains a civic leader by sharing her time and expertise with several community and regional organizations and was recognized as the 2015 Rotary Civic Award Winner, the 2016 Indiana Commission for Women Torchbearer Award and Trailblazer Award, and the 2017 Boy Scouts of America Buffalo Trace Council Distinguished Citizen Award; and

WHEREAS, Dr. Bennett served as a role model for colleagues and students at the University where her strategic approach, sense of humor, and open door were greatly valued; and
