NATIONAL GUARD SUPPLEMENTAL GRANT (NGSG)

ELIGIBILITY REQUIREMENTS AND INSTRUCTIONS

PROGRAM HIGHLIGHTS

National Guard Supplemental Grant (NGSG) - a grant that ensures up to 100% of tuition and fees for Undergraduate and Master's level studies, will be funded by the State of Indiana for eligible members of the Indiana National Guard.

The NGSG covers tuition and regularly assessed fees, not room and board or textbooks. The NGSG can only be used in the fall and spring semesters. It is subject to available funds.

- The grant amounts are based on credit hours per semester up to 15 credit hours.
- NGSG is a once a year application that resets every June.
- Funds are based upon availability and annual budget set by the State of Indiana Legislation.
- Application process is done through https://scholartrack.che.in.gov/
 - Applications must be submitted no later than 5 days before the beginning of classes; late applications are considered on a case-by-case basis.
 - The Indiana National Guard reserves the right, in cooperation with I-CHE, to revoke for cause the NGSG at any time.

Applicants will need to monitor their accounts for award offers; once offered, award letters need to go to university Bursar/Financial Aid offices.

- 1. Must be in an active drilling status
- 2. Must not be coded as AWOL within a 12-month period
- 3. Must not ETS before the end of the semester
- 4. Must not have any active FLAGs
- 5. Be a High School graduate or have a GED.

GOLD Phase:

- 1. Must be in an active drilling status
- 2. Must not be coded as AWOL within a 12-month period
- 3. Must not ETS before the end of the semester
- 4. Must not have any active FLAGs
- 5. Be a High School graduate or have a GED.
- 6. Must have applied for and been approved for FTA funding via GoArmyEd.com 30 days prior to classes beginning

All other Phases must meet the requirements listed in RED Phase.

AIR GUARD

Airmen:

- 1. Must be in an active drilling status
- 2. Must not be coded as AWOL within a 12-month period
- 3. Must not ETS before the end of the semester
- 4. Must not have any active FLAGs
- 5. Be a High School graduate or have a GED.

ROTC/OCS

Contracted Cadets:

- 1. Must be in an active drilling status
- 2. Must not be coded as AWOL within a 12-month period
- 3. Must not ETS before the end of the semester
- 4. Must not have any active FLAGs
- 5. Be a High School graduate or have a GED.
- 6. Must have applied for and been approved for FTA funding (if eligible), until contracted.
- 7. Upload signed copy of DA 597 during the application process OR email document to Program Manager

Officer Candidates:

- 1. Must be in an active drilling status
- 2. Must not be coded as AWOL within a 12-month period
- 3. Must not ETS before the end of the semester
- 4. Must not have any active FLAGs
- 5. Be a High School graduate or have a GED.
- 6. Must have applied for and been approved for FTA funding via ArmylgnitED.com 30 days prior to classes beginning (if eligible)
